SECTION 4: First-aid measures

4.1 Description of necessary first-aid measures

General advice	Do not get in eyes, on skin or on clothing. Do not breathe dust or mists. If inhaled	Remove person to fresh air and keep comfortable for breathing. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth. Immediately call a Poison Control Center or doctor for treatment advice.

In case of skin contact	Take off immediately all contaminated clothing. Rinse skin with plenty of water for 15-20 minutes. Wash contaminated clothing before reuse. Call a Poison Control Center or doctor if irritation persists.
In case of eye contact	Hold eyelid open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present and easy to do, after the first 5 minutes, then continue rinsing. Immediately call a Poison Control Center or doctor for treatment advice.
If swallowed	Rinse out mouth. Have person sip a glass of water if able to swallow. Do NOT induce vomiting unless told to do so by a Poison Control center or doctor. Do not give anything by mouth to an unconscious person. Immediately call a Poison Control Center or doctor for treatment advice.
