### Precautionary Statements:

**Prevention:** Keep away from heat. Store away from ammonia, acids, organic materials, reducing agents, flammables and combustible materials. Do not breathe dust or mists. Wear protective rubber gloves and chemical splash goggles when using this product. Mix ONLY with water. Take any precaution to avoid mixing with combustibles. Wash thoroughly after handling.

**Response:** **In case of fire:** Use flooding amounts of water to extinguish. Avoid dry chemicals containing ammonium phosphate. **If swallowed:** Rinse out mouth. Do NOT induce vomiting. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a Poison Control Center or doctor for treatment advice. **If on skin (or hair):** Wash with plenty of water. Call a Poison Control Center or doctor for treatment advice if irritation persists. **If inhaled:** Remove person to fresh air and keep comfortable for breathing.
